

request to continue the case in order to be present. Southfork Nursing Home refused to permit Campbells to transport Mrs. Dunn to the emergency hearing against her. Randall Dunn ultimately received full guardianship of Betty Dunn.

SS. On 10/17/24, Campbells served a copy of Mrs. Dunn's 07/16/24 Fulton County Ambulance Run Report to Randall Dunn's attorney and faxed the report to Fulton County Probate Judge McSpadden with a cover letter. Campbells did not get an opportunity to file the report in Mrs. Dunn's case, because Judge McSpadden telephoned Campbells home threatening Campbells with contempt of court if they ever file anything in Mrs. Dunn's case other than a petition. Judge McSpadden alleged he would not read what Campbells faxed. **(Ex. 21 and Ex. 33)**

TT. On 01/03/25 at 3:11 PM, Mr. O'Dell admitted Campbells' 4/01/24 preserved video evidence was destroyed by posting publicly on Facebook, "*The 4-1 video they claim city council destroyed, was not destroyed. The security company deletes videos after a month. They cannot keep it forever. These people lie and misrepresent with no regard for reality.*" **(Ex. 30, P. 44)**

UU. On 01/03/25 at 3:11 PM Mr. O'Dell also admitted his homosexual-allegation speech was done in retaliation, as he admitted, "*the Campbells had called for all of city council, the whole Police department, the mayor, and the City attorney to resign because of corruption. That's why I gave that speech. We made copies of all the correspondence for everybody who was there so they could read if they wanted to.*" **(Ex. 30, P. 44)** An issue is, Mr. O'Dell, et al failed to include copies of O'Dell's email correspondence where he objected to being called, "*Pastor.*" O'Dell purposely

concealed his aggression from simply being called, “*pastor.*”

VV. On or about 01/10/25, Campbells posted on their billboard sign, “*BARRY.ODELL.5 ON FACEBOOK – 1/3/24 AT 3:11 PM. CHECK OUT POST & ITS EDIT. TALK ABOUT LIBEL.*” (Ex. 30, P. 50) Mr. O’Dell then posted publicly on Facebook: “*I have posted several times about Dave and Dawn Campbell, as you know. Went to the office this AM to do work and here is their sign for today. I’ll repost a screenshot of the FB post for those who missed it, among others that show these people to be hypocritical liars.... Here is just a small sample of some of the lies they have told about me - and there is much more!*” Mr. O’Dell’s post was “*smoke and mirrors,*” because he failed to provide evidence of any lies made by Campbells while falsely alleging, “*here is just a small sample.*” Instead of providing a “*sample,*” O’Dell committed fraud in his 01/10/25 post, by making a major material misrepresentation about which O’Dell post Campbells referred to, which is the post dated 01/03/24 at 3:11 PM. (Ex. 30, P. 44) O’Dell falsely alleged Campbells were referring to his post made on 01/03/25 at 12:57 PM. (Ex. 30, P. 49) On 01/10/25 O’Dell falsely alleged, “*The June (sic) post they are whining about.*” O’Dell defrauded the public by showing the wrong post. In lieu of evidencing any lies made by Campbells, O’Dell provided an altered image from Campbells’ website where it appears he removed the word “*permanent*” from the word “*license*” to misrepresent. (Ex. 30, P. 52(a))

WW. O’Dell made another misrepresentation about Campbells on 01/10/25, by falsely alleging, “*They are all about their free speech. Why block so many people from your FB when you’re constantly posting about them.*” (Ex. 30, P. 50) In reality, O’Dell

“*constantly*” posts about Campbells and is actually the one who blocked Campbells’ personal Facebook page. O’Dell is not blocked by Campbells. Campbells are also unconstitutionally blocked by the City of Mammoth Springs’ Facebook page.

XX. On 03/02/25, O’Dell continued to misrepresent the public about Campbells. O’Dell posted Campbells’ Facebook Profile Image with the words, “*Unless we don’t like what you say. Then we’ll just block you!*” O’Dell’s twisted reality to deflect the fact it is Campbells who are blocked and had their 1st Amendment violated by the City of Mammoth Spring, enacted primarily by O’Dell. O’Dell perverted reality by indicating Campbells are a Government entity in lieu of the City, to which the Constitution applies. O’Dell’s misrepresentation caused his friends to appear to be talking about Campbells in the comments, which they could not be, because Campbells do not know who the people are in the comments and notified them. One person confirmed they were talking about someone else. O’Dell confused in order to misrepresent about Campbells. **(Ex. 30, P. 53)**

YY. On 02/07/25, Campbells visited the Southfork nursing home after seeing an invitation for the public to attend a yard sale/bake sale. Mrs. Betty Dunn was rolling down the hallway in a wheelchair. Campbells said hello to Betty, who informed Campbells she is “*devastated*” due to the “*boss end*” that “*voided*” her. Dawn Campbell asked Mrs. Dunn if Randy Dunn was treating her well and Mrs. Dunn began losing her composure by placing her hands on top of her head and stating, “*I don’t know.*” Mrs. Dunn began to loudly cry, which caused an attendant to ask Mrs. Dunn if she needed assistance. Mrs. Dunn *stated* “*no*” and made a shooing motion with her arms. The attendant asked Mrs. Dunn if she wanted to go back to her room and she

stated, “no.” Mrs. Dunn stated to Campbells, “*You said –*” Mrs. Dunn stated, “*I trusted you two more than anyone in the world.*” Administrator Gavin Moore made a false police report against Campbells, despite knowing about their body cams. **(Ex. 28)**

ZZ. On 02/11/25, Campbells filed formal charges against those who lied to cause Dave Campbell’s arrest and against Louise Alexander for her 09/22/24 assault. Chief Turnbough quickly shut Campbells down and instructed Campbells to stop bothering him, Mayor Busch, Barbara Gann and Melissa Rogers. Turnbough alleged Campbells must talk to his attorneys about the City’s business. Campbells then consulted with Turnbough’s attorney, John T. McGinnes, who alleged there was a misunderstanding and Turnbough was talking about the Fulton County Prosecuting Attorney, which is prejudicial and suspicious, especially since on 03/07/25, Prosecutor Drew Smith alleged he is finished communicating pertaining to his four alleged charges. **(Ex. 34, P. 4)** Prosecutor Smith fraudulently placed Dave Campbell in the false light of a felony charge by deceitfully opposing Campbell’s Motion to Dismiss and irrelevantly arguing it is irrelevant whether the forged affidavit is sworn, because a police officer can arrest without a warrant in a felony case.. **(Ex. 34, P. 3)**


AAA. It is beyond a reasonable doubt, O’Dell behaves adversarial against Campbells and concocts imaginary allegations he cannot support. O’Dell admitted on 01/03/25, he spoke out against Campbells on 06/10/24 for sending 06/06 resignation requests. On 06/18/24, Campbells served O’Dell a “*Letter of Rebuke / Cease Notice,*” which resulted in O’Dell committing a major act of retaliation against Campbells by conspiring in an unlawful arrest of Dave Campbell. **(Ex. 15)**

BBB. On 03/03/25, Honorable Meyer set Turnbough’s Cause No. 25CV-24-72

for a hearing, wherein the alleged lies made by Campbells should be revealed by O'Dell and Turnbough along with the issue of the City's evidence spoliation. **(Ex. 35)**

CCC. In Cause No. 25CV-24-72, Turnbough retaliated against Campbells and defrauded the Court by falsely alleging a witness statement provided by Campbells is a letter about him accusing him of not doing his job. **(Ex. 31)**
