On 2/7/2024, the Salem Police Department was dispatched to Southfork River Living and Therapy regarding two individuals, later identified as Dave and Dawn Campbell, who the caller, an administrator at the nursing home identified as Gavin Moore, stated Dave and Dawn were not allowed to be visiting with a certain resident and were asked to leave, however the two began causing "a scene." Upon arriving on scene, I spoke with Gavin, who stated Dave and Dawn had entered the nursing home with what appeared to be body cameras on themselves, initially telling staff they were there for the sale, which at the time the nursing home was having a baked goods sale. Gavin stated Dave and Dawn instead had went in to the 200 hall, which is where a resident, identified as Betty Dunn, was staying. Gavin explained Betty's son, identified as Randy Dunn (legal first name Randall), has court ordered guardianship on his mother and that he had a "verbal no contact order" between himself and Betty against Dave and Dawn, where Randy had previously verbally advised Dave and Dawn to not contact either himself or his mother. Gavin stated staff had seen Dave and Dawn make contact with Betty at her room the state of the state o

that room or at that end of the hallway and advised them to leave. Gavin stated at the time Betty was sick with a UTI, and appeared distressed at their presence. Gavin further stated Dave and Dawn were previously advised they could not be present at the nursing home and making contact with Betty, however he stated the recent incident was not reported to the police and was not officially reported in an incident report. Gavin stated following advising the two to leave, they got in an older model (possibly late 1990's model) white Ford F-250 pickup with a blue strip on the side and left the nursing home prior to my arrival.

I asked Gavin regarding the alleged no contact order, and Gavin stated the contact order was not suspected to be court ordered and only verbal based on the son's guardianship. I explained to Gavin if the "no contact order" is not ordered by a judge, law enforcement is limited in enforcing that order as it is not an official order. However, I advised Gavin due to this incident being reported to law enforcement, it being told to law enforcement the two had previously been advised to not speak with Betty or be inside the building in the area of Betty's room per staff's orders, and they returning today and violating the previously mentioned request of the staff knowing they have been told to not enter the building and be in that area of the building, and due to it being reported to law enforcement today that they have been advised a second time by facility staff to not return to the building in the 200 room area, if David and Dawn return at a later time violating facility staff orders and therefore trespass, law enforcement at a later time could pursue the issue as it would then constitute criminal trespass.

I later searched for court cases related to Betty, however the only case located was an open case involving Randall's guardianship of Betty. In this same court case (25PR-24-76), there is mention of Dave and Dawn Campbell, allegedly proposing video evidence to dispute the order of guardianship, alleging Betty, who according to the case notes has dementia, and that Dave and Dawn are challenging her son Randall and Betty's doctor Dr. Kauffman regarding the claims she has dementia. However, no where in the order was it seen that Dave or Dawn are barred from contacting Betty by a court order.

I later located a phone number for Dave in documents he submitted to the court, and made contact with Dave by phone. Dawn answered the phone, but put the phone on speaker where I could speak with both. I spoke with them regarding the incident at the nursing home. Dave advised they had not been previously told they could not go to Betty's room, however Dave also stated that he and Dawn were aware of the baked goods sale and stated the sale gave them an excuse to be at the nursing home and see if Betty was okay. Dave further stated Betty did appear to the distressed upon speaking to her, stating Betty made comments stated he and Dawn were "the only two she trusted." essentially becoming upset at their presence. Dave and Dawn then spoke regarding separate incidents involving the Sheriff's Office, Mammoth Spring Police Department. the Judge presiding over the guardianship, and a prosecuting attorney, as well as alleging EXHIBIT 28

Betty was "kidnapped" from her residence, as well as alleging the statements of Betty having dementia were fraudulent, however these incidents did not apply to the situation or to the Salem Police Department. However, Dave did allege he had proof of unlawful deeds of Dr. Kauffman, and that he wanted to submit them to the police department for investigation. I advised Dave he could submit those documents to the police department at a later time for the police department to look in to his claims.

While speaking with Dave and Dawn, they were both advised as per the wishes of hospital staff, they are being officially notified by the police department they are not allowed in the area of Betty's room or the wing of the 200 room area. Both indicated they understood and both stated they would not return to the nursing home.
