- 3. Estoppel: Counterclaim-Plaintiff's claims are barred, in whole or in part, by the doctrine of estoppel, based on Counterclaim-Plaintiff's prior representations or conduct which preclude them from asserting the claims.
- 4. Fraud: Counterclaim-Plaintiff's claims are barred, in whole or in part, by fraud perpetrated by the Counterclaim-Plaintiff, which undermines the validity of the claims.
- 5. Waiver: Counterclaim-Plaintiff's claims are barred, in whole or in part, by the doctrine of waiver, as Counterclaim-Plaintiff has knowingly and voluntarily relinquished any rights to assert the claims.

WHEREFORE, Counterclaim-Defendant respectfully requests that this Court dismiss the Campbell's Counterclaims in their entirety and grant any other relief the Court deems just and proper.
