1.) Defendants will not be unfairly prejudiced by the amendment of the petition because:

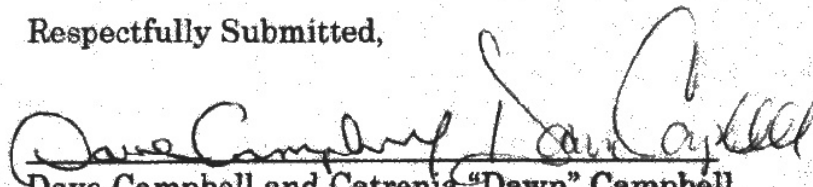
- a. Defendants have not yet answered Plaintiffs' complaints; and

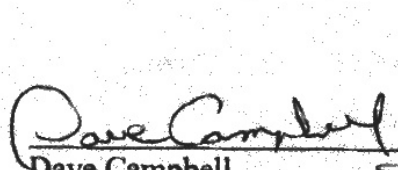

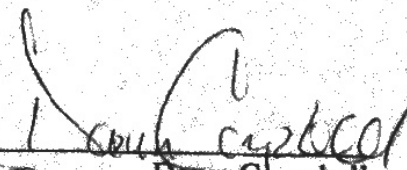
